

**TIMBERON GOLF COURSE

PROPERTY DESCRIPTION

BEING the description of a parcel of land to be known hereafter as Timberon Golf Course Subdivision Unit 3, lying in and being a portion of Sections 22 and 27, Township 19 South, Range 12 East, New Mexico Principal Meridian, Otero County, New Mexico, and being more particularly described by metes and bounds as follows:

BEGINNING at a point lying in the Northeastly Right of Way Line of River Side Road (50 foot wide), said point bears North 49° 39' 00" East along the center line of River Side Road a distance of 67.09 feet to a point; thence continuing along the centerline of River Side Road a distance of 274.06 feet along the arc of a curve to the right whose central angle is 58° 24' 00" whose radius is 268.88 feet and whose long chord bears North 78° 51' 00" East a distance of 262.35 feet to a point; thence continuing along the centerline of River Side Road a distance of 295.71 feet along the arc of a curve to right whose central angle is 23° 43' 00", whose radius is 714.38 feet and whose long chord bears South 60° 05' 30" East a distance of 293.60 feet to a point; thence North 41° 46' 00" East across River Side Road a distance of 25.00 feet from the point of centerline intersection of River Side Road with Winter Lane (50.00 foot wide) of Sacramento Mountain Ranches Subdivision Unit 3 in Otero County, New Mexico.

THENCE from said point of beginning and along the Northeastly right of way line of River Side Road a distance of 40.86 feet along the arc of a curve to the left whose central angle is 3° 10' 00", whose radius is 739.38 feet and whose chord bears North 49° 49' 00" West a distance of 40.86 feet to a point;

THENCE North 40° 00' 00" East a distance of 160.00 feet to a point;

THENCE South 60° 31' 22" East a distance of 162.94 feet to a point lying in the West right of way line of Torrey Pines Lane (50 foot wide).

THENCE along the west right of way line of Torrey Pines Lane a distance of 225.79 feet along the arc of a curve to the left whose central angle is 16° 03' 00", whose radius is 806.03 feet and whose chord bears North 23° 44' 30" East a distance of 225.05 feet to a point;

THENCE a distance of 31.41 feet along the arc of a curve to the left whose central angle is 90° 00' 00", whose radius is 20.00 feet and whose long chord bears North 29° 17' 00" West a distance of 28.28 feet to a point lying in the southerly right of way line of Eldrado Drive (50 foot wide); the following calls being along the right of way line of Eldrado Drive unless otherwise specified;

THENCE North 74° 17' 00" West a distance of 100.00 feet to a point;

THENCE a distance of 237.94 feet along the arc of a curve to the right whose central angle is 77° 43' 00", whose radius is 175.42 feet and whose long chord bears North 35° 25' 30" West a distance of 220.12 feet to a point;

THENCE North 3° 26' 00" East a distance of 533.81 feet to a point;

THENCE a distance of 31.41 feet along the arc of a curve to the left whose central angle is 90° 00' 00", whose radius is 20.00 feet and whose long chord bears North 41° 34' 00" West a distance of 28.28 feet to a point;

THENCE North 86° 34' 00" West a distance of 105.00 feet to a point;

THENCE a distance of 306.14 feet along the arc of a curve to the right whose central angle is 31° 37' 00", whose radius is 554.79 feet and whose long chord bears North 70° 45' 30" West a distance of 302.27 feet to a point;

THENCE North 54° 57' 00" West a distance of 278.21 feet to a point;

THENCE a distance of 203.84 feet along the arc of a curve to the right whose central angle is 9° 57' 00", whose radius is 1173.78 feet and whose long chord bears North 49° 58' 30" West a distance of 203.58 feet to a point;

THENCE North 45° 00' 00" West a distance of 648.56 feet to a point;

THENCE a distance of 196.03 feet along the arc of a curve to the left whose central angle is 8° 08' 00", whose radius is 1380.98 feet and whose long chord bears North 49° 04' 00" West a distance of 195.87 feet to a point;

THENCE North 53° 08' 00" West a distance of 100.02 feet to a point;

THENCE a distance of 391.64 feet along the arc of a curve to the right whose central angle is 107° 12' 00", whose radius is 209.32 feet and whose long chord bears North 0° 28' 00" East a distance of 336.96 feet to a point;

THENCE North 54° 04' 00" East a distance of 427.14 feet to a point;

THENCE a distance of 349.08 feet along the arc of a curve to the right whose central angle is 50° 30' 00", whose radius is 396.05 feet and whose long chord bears North 79° 19' 00" East a distance of 537.89 feet to a point;

THENCE a distance of 31.41 feet along the arc of a curve to the left whose central angle is 90° 00' 00", whose radius is 20.00 feet and whose long chord bears North 59° 34' 00" East a distance of 28.28 feet to a point lying in the westerly right of way line of Rio Pinar Drive (50 foot wide);

THENCE North 14° 34' 00" East along the westerly right of way line of Rio Pinar Drive a distance of 316.41 feet to a point;

THENCE South 75° 26' 00" East across Rio Pinar Drive a distance of 50.00 feet to a point lying in the easterly right of way line of Rio Pinar Drive;

THENCE South 44° 24' 50" East a distance of 219.12 feet to a point;

THENCE South 70° 36' 20" East a distance of 108.17 feet to a point;

THENCE South 58° 41' 00" East a distance of 368.57 feet to a point;

THENCE South 61° 45' 00" East a distance of 530.87 feet to a point;

THENCE South 14° 13' 37" East a distance of 195.73 feet to a point;

THENCE South 20° 13' 00" West a distance of 506.05 feet to a point;

THENCE South 15° 19' 57" West a distance of 122.68 feet to a point;

THENCE South 1° 45' 00" East a distance of 276.72 feet to a point;

THENCE South 3° 26' 00" West a distance of 875.00 feet to a point;

THENCE South 11° 40' 00" East a distance of 153.13 feet to a point lying in the northerly right of way line of Eldrado Drive;

THENCE South 74° 17' 00" East along the northerly right of way line of Eldrado Drive a distance of 126.13 feet to a point;

THENCE South 15° 43' 00" West across Eldrado Drive a distance of 50.00 feet to a point lying in the southerly right of way line of Eldrado Drive;

THENCE North 74° 17' 00" West along the southerly right of way line of Eldrado Drive a distance of 55.00 feet to a point;

THENCE a distance of 31.41 feet along the arc of a curve to the left whose central angle is 90° 00' 00", whose radius is 20.00 feet and whose long chord bears South 60° 43' 00" West a distance of 28.28 feet to a point lying in the easterly right of way line of Torrey Pines Lane (50 foot wide);

THENCE along the easterly right of way line of Torrey Pines Lane a distance of 389.20 feet along the arc of a curve to the right whose central angle is 26° 03' 00", whose radius is 865.03 feet and whose long chord bears South 28° 44' 30" West a distance of 385.86 feet to a point;

THENCE South 41° 46' 00" West continuing along the easterly right of way line of Torrey Pines Lane a distance of 33.51 feet to a point;

THENCE North 74° 17' 00" West along the southerly right of way line of Eldrado Drive a distance of 55.00 feet to a point;

THENCE a distance of 31.41 feet along the arc of a curve to the left whose central angle is 90° 00' 00", whose radius is 20.00 feet and whose long chord bears South 3° 14' 00" East a distance of 28.28 feet to a point lying in the northeasterly right of way line of River Side Road;

THENCE North 48° 14' 00" West along the northeasterly right of way line of River Side Road a distance of 195.67 feet to the Point of Beginning of the parcel being described and containing 59.752 acres more or less.

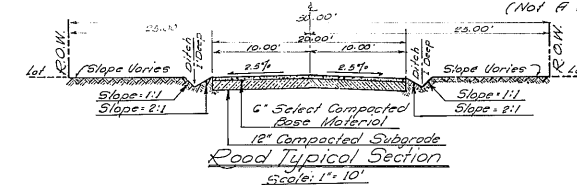
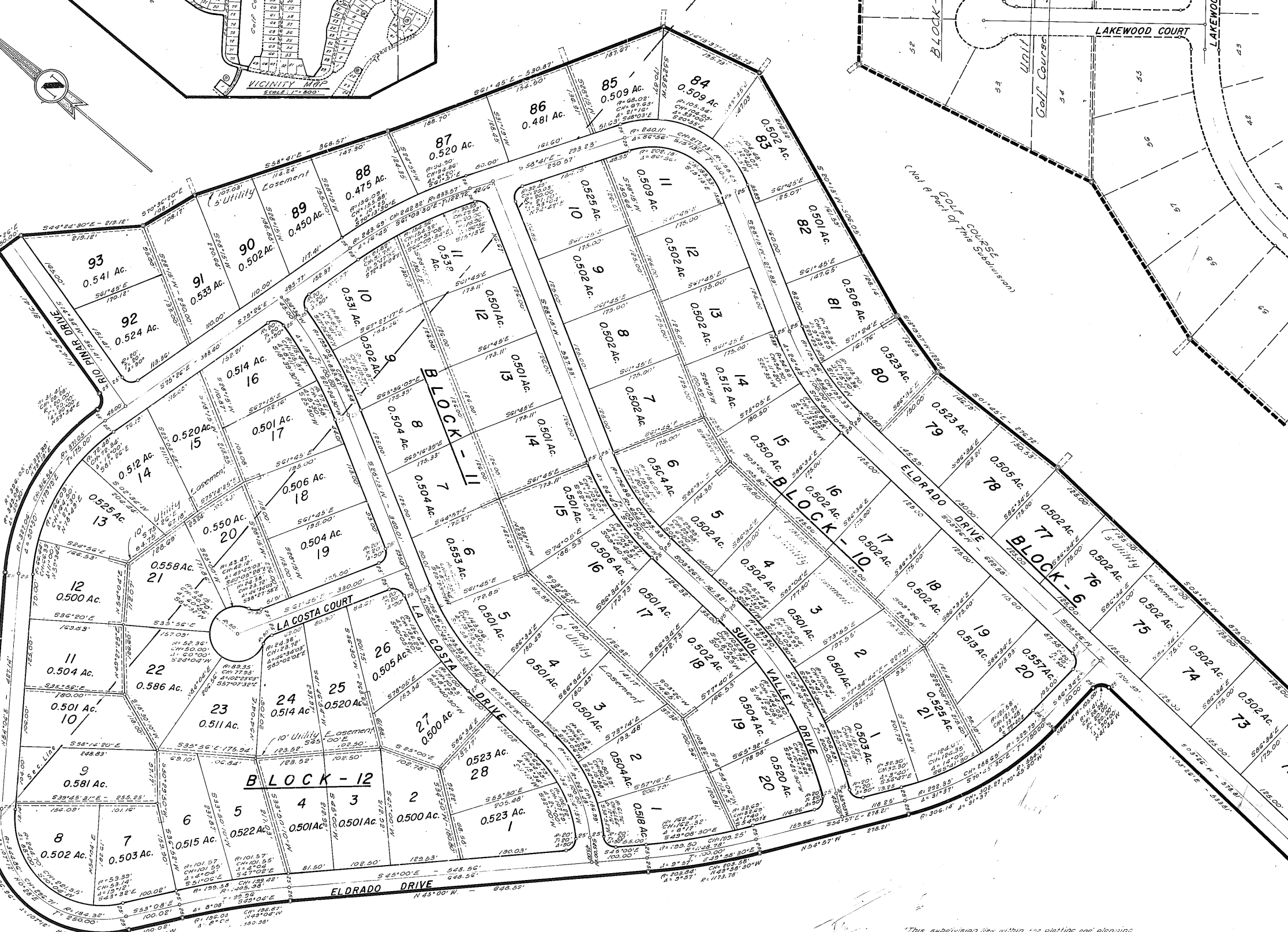
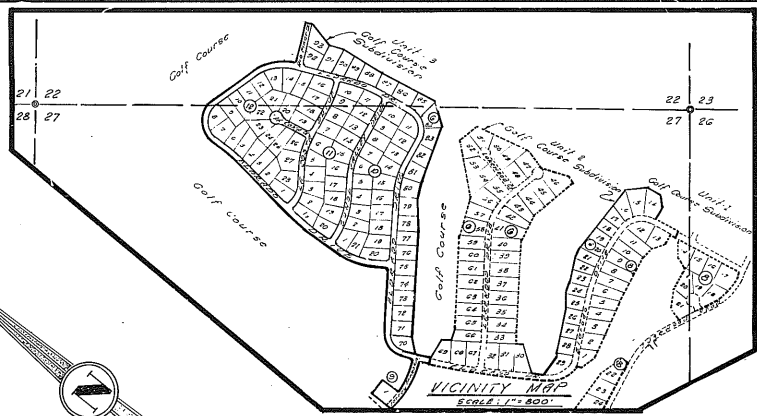
